


## **Fraud Prevention Tips**

Higher Education fraud continues to be a growing threat to college campuses as the sophistication of fraud techniques continue to evolve. College Ave aims to provide schools with information on best practices to deter and mitigate student loan fraud. The information below can serve your team as a reference and resource to assist in identifying and reducing fraud risks on your campus.



#### What is fraud? Three main types:

- 1. First Party Fraud: In first party fraud, the student is the beneficiary of the proceeds, the fraud is usually self-reported by the alleged victim, and the victim knows the suspect. For example, the victim is the parent of the student whose name and information is unknowingly being used by the suspect to receive funding.
- 2. Third Party Fraud: This is the most common type of fraud. Generally known as identity theft, the suspect steals borrower/cosigner information, and the borrower who is listed on the application is not attending school.
- 3. Synthetic Fraud: This is a new and growing type of fraud where the borrower does not exist. The identity is generally a combination of real and fabricated information, and the criminal activity is sophisticated and complex to uncover.

#### Trends to look out for:

- A sudden increase of students applying only for private student loans (PSL), not filing a FAFSA and forgoing other sources of financial assistance.
- Students admitted to low-cost academic programs with limited admission criteria and applying only for PSL.
- An increase in the number of students attempting to enroll past well-known published deadlines.

- For colleges offering online classes with limited admission criteria, an unusual number of students enrolling from one location or from states across the country.
- An influx of admission applications that are abnormally high in a short period of time.
- A rise in withdrawals and class absences, especially students with PSL.
- A surge in FAFSA applications in a single day.

#### Fraud Prevention Tips:

- 1. Question any situation that does not look right.
- 2. Issue a campus-wide employee alert of emerging fraud trends. Be sure to include your leadership, admissions, registrar, business office, academics, and your IT department.
- 3. For institutions who have a relationship with a bank or third party to manage refunds, ask if trends are emerging. For example, multiple students using the same account or an increase in out-of-state students opening accounts.
- 4. Your IT department should investigate unusual student account activity, such as a single IP address creating/accessing multiple accounts, spot checking out-of-state street address authenticity, and increases in requests for school email addresses.
- 5. Investigate any increases in V4 requests of FAFSA students to verify identity.
- 6. Encourage faculty to report unusual increases in withdrawals or no-shows.

#### Additional Action:

- Work with PSL lenders and advise them of any suspicious applications to mitigate fraud.
- Reach out to state associations and local institutions to share information and fraud trends.
- Contact your regional OIG to discuss and plan a fraud prevention workshop for employees.
- Familiarize your institution with compliance responsibilities for reporting fraud.

#### Ask Yourself:


- 1. Are you able to confirm identities of students who apply, are accepted, and attend your institution, or is that handled by another office? Do you share information?
- 2. What is your process when you identify federal or private fraudulent loans?
- 3. Will you notify PSL lenders if there is a fraudulent borrower, especially with a pending certification from that lender?
- 4. When you certify a PSL, do you confirm they are enrolled and attending your school?
- 5. Has there been an abnormal amount of PSL refunds being issued?

Fraud is a growing and ever-changing challenge. By sharing information with one another, staying abreast of fraud developments, and taking immediate action, you can help to mitigate this growing nuisance on your college campus.

### **FSA Announces FAFSA Soft Launch Timeline**

As previously announced in November, students and families will be able to complete and submit the 2024-2025 FAFSA form online starting December 31. However, on December 18, 2023 FSA sent an <u>electronic announcement</u> stating, "We will be treating the period leading up to and following Dec. 31 as a soft launch period, which will allow us to monitor and respond in real time to any potential issues impacting the applicant experience." After the long awaited release of the FAFSA this comes as a bit of a shock to institutions who are looking ahead to the new year for planning FAFSA completion events

#### What to Expect During the Soft Launch of the FAFSA

- Contributors, including those without a SSN, will be able to create a StudentAid.gov account (available Dec. 31)
- FSA will initiate planned pauses for site maintenance and updates as needed to create a better FAFSA experience.
- Applicants may experience a "waiting room" feature, to help control website volume.
- Students who complete their form during this period, will have their information stored for processing.
- Once a students section is complete if a contributor can't access the site due to maintenance, the contributor can return to complete their portion once the site becomes available again.
- If FSA initiates site maintenance while a student or contributor is completing an application, they will be able to continue until they have completed the form.
- After all sections of the FAFSA are completed and submitted, students will receive an email noting their

submission date, estimated SAI, and estimated Pell eligibility. However, students won't receive a FAFSA Submission Summary until FSA processes it, beginning in late January.

#### What This Means for Institutions, State Aid Agencies, and College Access Partners

FSA recommends that as institutions develop FAFSA completion events to plan for the possible impacts the "soft launch" might create during late December and January. If possible, scheduling these events to take place in later January and into February. FSA also suggests that institutions may need to amplify key messages with students and families to clarify the FAFSA schedule and terms of the soft launch period.

In the meantime institutions can encourage students and families to access StudentAid.gov to learn more. FSA will be updating the site to include basic information about the soft launch and the changes applicants can anticipate. Additionally FSA will be providing online resources for completing the 2024-25 FAFSA soon. Including, instructions for creating a StudentAid.gov account without a Social Security number, how to complete the new 2024-25 FAFSA form, and what to do before and after completing the FAFSA form. These resources will be made available on StudentAid.gov closer to the 2024-25 FAFSA launch.
