

# FAFSA Simplification Fun Fact #5

CHANGES TO THE FAFSA MEAN STUDENTS WILL NO LONGER BE ASKED IF THEY ARE "INTERESTED IN WORK STUDY".

#### PDT Lunch and Learn Recap

Thank you to all of you who attended our third virtual lunch and learn series on October 10. Even with the RMSAFAA conference in full swing just down the road we had over 50 attendees. The training was led by the now retired Jim Ciha, Loan Processor with Colorado Mesa University. He discussed the changes occurring to SAI methodology and how the Federal Pell Grant will be calculated.

The new need analysis formula removes the number of family members in college from the calculation, and includes asset information from small farm and business owners, it also allows a minimum SAI of -1,500, and implements separate eligibility determination criteria for Federal Pell Grants.

The FAFSA Simplification Act extends the Federal Pell Grant to more students and links eligibility to family size and the federal poverty level.

Beginning in the 2024-25 award year, the Pell Grant scheduled award calculation consists of three steps.

- Max Pell: Students with an SAI value between -1500 and 0 will qualify for the Maximum Pell.
- SAI Calculated Pell: Students having a positive SAI value will have a Scheduled Pell Grant determined using the following formula: Scheduled Pell Grant= Maximum Pell - SAI (rounded to the nearest \$5)
   If the calculated Scheduled Pell Grant is less than Minimum Pell Grant,

the student does not qualify for a Scheduled Pell Grant, but may be eligible for the Minimum Pell based on family size, AGI and the poverty threshold in your state.

• Minimum Pell: Minimum Pell Grant will likely be established as 10% of the Maximum Pell Grant. The minimum Pell grant would be calculated as follows: Minimum Pell = Maximum Pell x .10 (rounded)

The dollar amounts for maximum and minimum Pell are still being determined by the Federal Government. Students eligible to receive Maximum or Minimum Pell will be flagged on their ISIRS imports.

The PDT Committee hopes that you have found value in these virtual sessions.
